**SUMMARY ANNUAL REPORT

This is a Summary of the Annual Report for the Electrical Construction Industry Vacation-Holiday Plan (the "Plan"), (Employer Identification No. 39-1038147, Plan No. 503) for the period June 1, 2016 to May 31, 2017. The Annual Report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan has committed itself to pay the following types of claims incurred under the terms of the Plan: Vacation and Holiday claims.

BASIC FINANCIAL STATEMENT

The value of Plan assets, after subtracting liabilities of the Plan, was \$10,719,983 as of May 31, 2017 compared to \$9,986,298 as of June 1, 2016. During the Plan year the Plan experienced an increase in its net assets of \$733,685. This increase includes unrealized appreciation or depreciation in the value of Plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the Plan year, the Plan had total income of \$10,843,599. This income included employer contributions of \$10,778,227, realized losses of \$16,914 from the sale of assets and earnings from investments of \$82,286.

Plan expenses were \$10,109,914. These expenses included \$340,723 in administrative expenses and \$9,769,191 in benefits paid to participants and beneficiaries.
