**SUMMARY ANNUAL REPORT
FOR THE

This is a Summary of the Annual Report for the Electrical Construction Industry Annuity Plan (the “Plan”), (Employer Identification No. 39-1711748, Plan No. 001) for the period June 1, 2019 to May 31, 2020. The Annual Report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENT

Benefits under the Plan are provided by a trust (benefits are provided in whole from trust funds). Plan expenses were \$13,223,526. These expenses included \$386,700 in administrative expenses and \$12,836,826 in benefits paid to participants and beneficiaries. A total of 4,013 persons were participants in or beneficiaries of the Plan at the end of the Plan year, although not all of these persons had yet earned the right to receive benefits.

The value of Plan assets, after subtracting liabilities of the Plan, was \$271,011,492 as of May 31, 2020 compared to \$252,444,235 as of June 1, 2019. During the Plan year the Plan experienced an increase in its net assets of \$18,567,257. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the Plan’s assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the Plan year, the Plan had total income of \$31,790,783, including employer contributions of \$7,833,340, employee contributions of \$2,979,541, other contributions (including rollovers) of \$49,817, and earnings from investments of \$20,928,085.

The Plan has a contract with *John Hancock Retirement Plan Services* which allocates funds toward individual accounts.

These portions of the report are furnished without charge.
