

IMPORTANT NOTICE TO PARTICIPANTS IN PAY STATUS

Dear Participant:

December 16, 2024

The Board of Trustees is pleased to inform you that the benefit rate under the Plan will increase for work performed during the period June 1, 2010 through May 31, 2018.

Effective January 1, 2025, the Basic Benefit for Participants shall be increased by the dollar amount set forth below for each Plan Year between June 1, 2010 and May 31, 2018 in which such Participant earned at least one-quarter of a year of Benefit Credit. This benefit increase shall apply to all individuals whose pension benefits hereunder are in pay status as of January 1, 2025, including pensioners, beneficiaries and alternate payees. For those in pay status before January 1, 2025, the benefit increase shall become effective January 1, 2025 (it is not retroactive). The benefit increase will not be adjusted due to (1) an individual's age at benefit commencement, (2) form of payment elected, or (3) whether a Participant's benefit is subject to a QDRO. Participants shall receive the monthly benefit increase as outlined in the following chart, with their Participant group determined by the collective bargaining agreement under which they were employed during the relevant period:

Example: Jim is an inside wireman who qualifies for the increase of \$17.00 per plan year and worked from Jule 1, 2010 through May 31, 2018. He began receiving his pension before 2025. His monthly benefit amount will increase by \$136.00 (8 years x \$17.00 = \$136.00) effective January 1, 2025.
